Dan Fishel: Concerned about articles in the Detroit Free Press regarding land use permits for huckleberry picking, mushroom picking and cross-country skiing and would like the Council to look at it and do something about it.

Moved by Murphy, seconded by Butler, to accept the Rural Task Force road project on Division Street. Ayes: Suvada, Morris, Carlson, Murphy, Adams, McKee and Butler. Nays: None. The motion carried.

COMMITTEE REPORTS

Trustee Morris reported that the Ordinance Committee will be meeting February 2, 2011 at 1:00 PM at Village Hall.

M-18 PROPERTY DEVELOPMENT

Weyerhaeuser is the only one that responded to clear 33 acres in the amount of \$16,740. Discussion concerning removal of trees and stumps.

Moved by Butler, seconded by Suvada, to engage in a contract with Weyerhaeuser for the development of the M-18 property, Village will be receiving \$16,740, and authorize Tim Sadowski and President Carlson to sign the contract. Discussion about the water main and DEQ permits.

Moved by Butler, seconded by Adams, to accept the proposal from May and Associates for the water main extension and RFP for \$2,205. Ayes: Butler, Suvada, Murphy, McKee, Adams, Carlson and Morris. Nays: None. The motion carried.

Moved by Murphy, seconded by Butler, to accept the commercial entrance engineering and RFP with May & Associates in the amount of \$2,420. Ayes: McKee, Carlson, Adams, Morris, Butler, Suvada and Murphy. Nays: None. The motion carried.

INDUSTRIAL PARK DEVELOPMENT

Development in the industrial park is cost prohibitive at this time. Trustee Adams would like Manager Sadowski to collaborate with the DDA for Industrial Park improvements.

CEMETERY EXTENSION

Trustee Butler updated the Council on the 1/20/11 Cemetery Board Meeting with the DNR about the possible purchase of state land for the cemetery.

SHOP LIGHTING

Manager Sadowski relayed the DPW's request to upgrade the lights in the shop.
