Minutes of the March 12, 2012 Regular Council Meeting

President Erine Adams called the meeting to order at 7:00 PM. Members of the Council present: Joan Murphy, Marc McKee, Mike Butler, Erine Adams, Jon Michael Suvada, Bruce Yannatta and Diane Lippert. The Pledge of Allegiance was recited and an Invocation given by Trustee Butler.

President Adams added Town Hall Meeting under Unfinished Business.

REGULAR AGENDA

Moved by Butler, seconded by McKee, to approve the Regular Agenda with the addition. All in favor. Hearing no objections, the motion carried.

PUBLIC COMMENT ON REGULAR AGENDA ITEMS

Bev Luther: Comments on the Social Host Liability Awareness Month.

CONSENT AGENDA

Moved by McKee, seconded by Butler, to accept the consent agenda as presented. Ayes: Yannatta, Murphy, Suvada, Adams, Lippert, McKee and Butler. Nays: None. The motion carried.

SHERIFF'S REPORT

Deputy Tatrai presented the Sheriff Department's Report.

MANAGER'S REPORT

In addition to the written Manager's Report, Manager Lowe informed the council that the DDA Minutes are on the website, the DEQ cross-connection control program requirement, the MML training regarding the EVIP, alternative natural gas provider. Trustee Murphy had questions regarding the treasurer benefit information, the DPW putting up the banners, a typo regarding the year of the audit, reminded everyone that it is Sunshine Week and the report on benefits.

-Elected Officials' Compensation

President Adams gave the audience an opportunity to give their opinion on this subject.

Moved by Suvada, seconded by Murphy, to amend the policy to read that the Village will offer and pay 90% of the premium for health insurance and dental insurance for the clerk, treasurer and their families, beginning with the election in November of 2012. Ayes: Murphy, Yannatta and Suvada. Nays: Adams, Butler, McKee and Lippert. The motion failed.

Moved by Lippert, seconded by Murphy, to reduce the retirement from 13% to 10% for the elected officials, beginning with the election in November of 2012. Ayes: McKee, Adams, Lippert and Butler. Nays: Yannatta, Suvada and Murphy. The motion carried.

-GASB54 Policy

Manager Lowe gave an explanation of GASB 54.

Moved by Suvada, seconded by Yannatta, to pass the GASB 54 and the Fund Balance policy as written. Ayes: Butler, Yannatta, Adams, Murphy, McKee, Suvada and Lippert. Nays: None. The motion carried.
