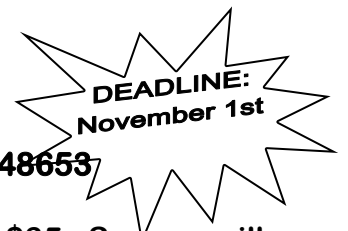

Spaces are limited to one (8' x 10') space per crafter at a cost of \$35. Spaces will be available in the large gym. A limited number of tables are available at \$5.

You must include photos of your craft items, booth set-up and you working on your craft, even if you have been in our show previously, with the enclosed completed application to be considered. Photos will be returned the day of the craft show.

There will be an early set up on Friday Nov. 30th. From 6-8 pm.

Set-up will be December 1, at 9 a.m. Enter the CRAF Center from the 3rd Street entrance. The Craft Show hours are: December 1st, from 11a.m. to 8 p.m. You must stay until 8:00 p.m.

Any crafter unable to attend must give a forty-eight (48) hour notice in order to receive a refund.

You must make all of your craft items. No wholesale products will be accepted and you will be asked to put such items away.

Please make your booth look like Christmas. (Tablecloths to cover your tables and Christmas decorations, etc.)

Registration will be assigned in the order received. Registration Deadline– November 1st. (Late Registration fee is \$45 after November 1st). Cashing of your check does not mean you are automatically accepted into the show. The committee will make the final decisions on Nov. 1st. If you are not accepted you will be refunded your money. You will be notified by email or regular mail.

You will receive your booth assignment at check in.

Booth Assignments will not be changed after November 20th. Christmas in the Village Committee's decision is FINAL.

If you want the same booth as last year, please indicate that on the application. If you want to be next a specific person, please indicate that on the application as well, in the provided area.

There are four (4) spots with electricity with a \$5 additional charge.
