- Where the drive occurs in curb section, existing curb will be completely removed and replaced with standard concrete driveway return.

**THE CONDITION OF THE PERMIT** shall be that applicant shall construct and maintain said driveway approach in accordance with Village specifications therefor and shall well and truly pay all damages, fines and penalties for which he/she shall become liable and shall save harmless and indemnify said Village against all suits, claims, damages and proceedings of every kind arising out of construction and maintenance of said driveway approach, including snow removal.
